

a/ Per Clause 2.1.3 of Canada's Grant Agreement, a part of Canada's contribution (the "Initial Funds") is not available for AMC disbursement until annual maximum cumulative contributions ("Subsequent Funds") have been disbursed. With payment of USD 10.12 million in 2014, Canada's payment reached the limit established for the year ending March 31, 2015 of USD 94.7 million (per Schedule 4 of Canada's Grant Agreement). The remaining amount of Canada's share (USD 26.3 million) was drawdown from the Initial Funds. Therefore, the remaining amount of Initial Funds not available for AMC disbursements is USD 51.8 million.
