Introduction

The Climate Risk and Early Warning Systems (CREWS) Initiative was officially launched at the 21st session of the UN Framework Convention on Climate Change (UNFCCC) Conference of the Parties (COP21) in Paris, France as part of the Solutions Agenda. It aims to strengthen and increase the capacity for Multi-Hazards Early Warning Systems, to generate and communicate effective impact-based early warnings and risk information for hazardous hydro-meteorological and climate events to protect lives, livelihoods, and property in Least Developed Countries (LDCs) and Small Islands Developing States (SIDS).

The CREWS Trust Fund was established in September 2016. This report covers the financial status of the CREWS Trust Fund, and is produced by the Trustee in accordance with the Trustee's role in the CREWS Governance Document, as set forth under Section 18, which states:

"The Trustee will provide to the Steering Committee regular reports on the financial status of the CREWS Trust Fund."

In addition, Section 8 of the Standard Provisions in the Contribution Agreement/Arrangement states, as follows:

"The Trustee shall maintain separate records and ledger accounts in respect of the funds in the Trust Fund and transfers made therefrom. The Trustee shall report to the Steering Committee annually unless otherwise agreed between the Trustee and the Steering Committee, on the financial status of the Trust Fund, including information on status of Contributions, investment income, commitments, transfers and funds available for allocation by the Steering Committee."



CREWS Trust Fund Financial Summary as of December 31, 2019

Pledges and Contributions:

A pledge represents a contributor's expression of intent to make a contribution. Pledges are formalized into Contributions by way of a Contribution Agreement/Arrangement between the Contributor and the Trustee.

As of December 31, 2019, contributions to the CREWS Trust Fund totaled US\$ 54.82 million. Of this amount, US\$ 43.59 million has been deposited into the CREWS Trust Fund.

Investment Income:

As of December 31, 2019, the CREWS Trust Fund earned investment income of approximately USD 0.66 million on the liquid balances of the Trust Fund. The CREWS Trust Fund balance is allocated to a short-term fixed income portfolio which has returned approximately 2.69% during calendar year 2019.

Funding Approvals:

As of December 31, 2019, the CREWS Steering Committee had approved funding from the CREWS Trust Fund totaling USD 36.54 million to cover projects and fees as well as administrative budgets to support the activities of the CREWS Secretariat and Trustee.

Cash Transfers:

The Trustee has transferred a total of USD 36.54 million up to December 31, 2019, of which USD 29.10 million is related to projects.

Funds Held in Trust:

Funds Held in Trust¹ reflect contributions paid-in from contributors and investment income earned, less cash transfers by the Trustee. Funds Held in Trust as of December 31, 2019 amounted to US\$ 7.72 million.

Funds Available for CREWS Steering Committee Funding Decisions:

Funds available to support CREWS Steering Committee funding decisions amounted to USD 7.72 million as of December 31, 2019.

HIGHLIGHTS FOR THE PERIOD OCTOBER 1, 2019 TO DECEMBER 31, 2019:

- The Trustee executed a contribution agreement with the United Kingdom for GBP 2 million. Funds were received during the period.
- The Trustee also executed a contribution agreement with Germany for EUR 10 million (approximately USDeq. 11.23 million valued as of December 31, 2019) with an instalment payment schedule from 2020 to 2022.

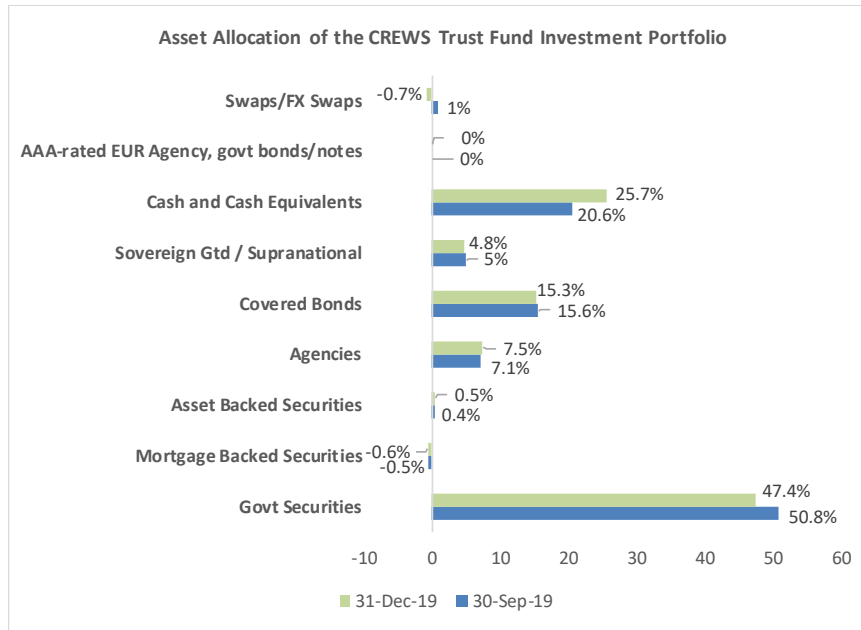


3. Asset Mix and Investment Income

ASSET MIX

Funds held in trust by the World Bank (as the Trustee) are maintained in a commingled investment portfolio (the “Pool”) for all trust funds administered by the World Bank. The World Bank uses the Conditional Value-at-Risk (CVaR) measure as the risk constraint in the management of trust funds. Funds are managed such that the expected maximum loss, as measured by the CVaR, at the portfolio’s investment horizon, is not to exceed 1% with 99% confidence.

The portfolio allocation by asset class has the largest allocations to government securities and money market instruments.

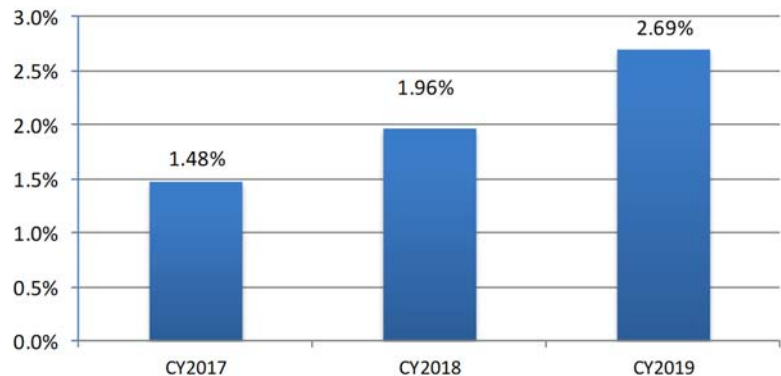


Note: The negative position in swaps is primarily due to changes in foreign currency exchange (FX) rates in cross currency basis swaps. Such swap instruments are used to implement currency hedges on bond positions within the portfolio. These hedges remain in place.

Mortgage Backed Securities allocation includes To-Be Announced (TBA) contracts for which only Mark-To-Market (MTM) is used to calculate the value of the position which, as a result, could be negative.

INVESTMENT RETURNS

The CREWS Trust Fund balances are invested in accordance with the investment strategy established for all trust funds administered by the World Bank. They are invested in a short-term fixed income portfolio with an investment horizon of one year. The CREWS Trust Fund portfolio has earned approximately USD 0.66 million in investment income since inception.
